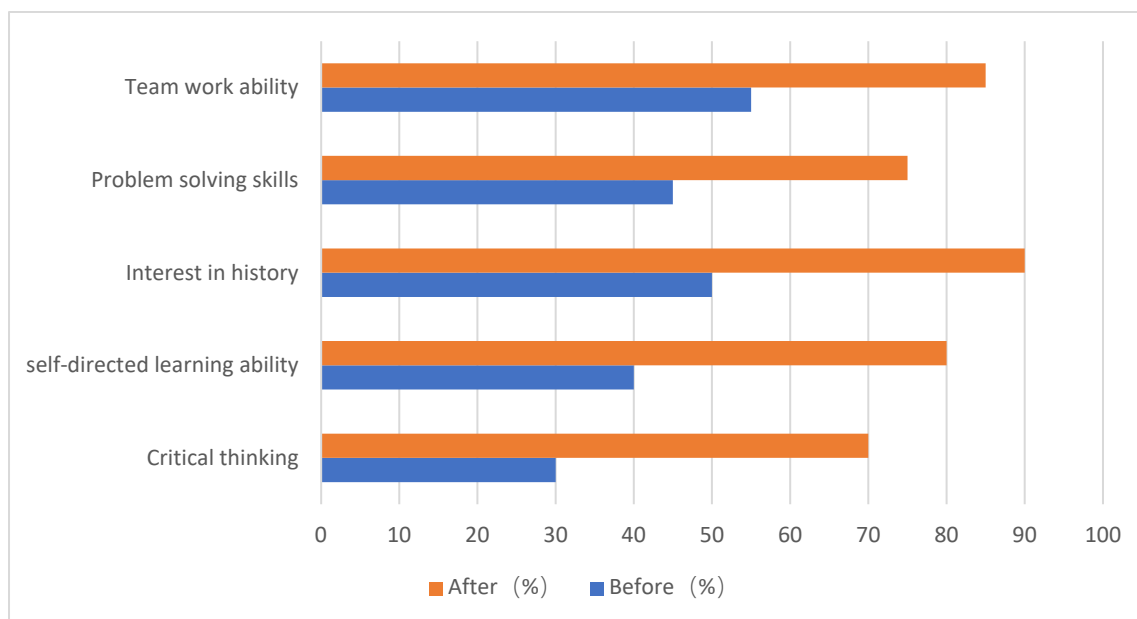


Figure 1. The change of students' learning ability before and after adhering to the personalization principle

These forms of engagement allow learners to internalize knowledge,

question assumptions, and ultimately build a more mature and reflective worldview. As such, placing students at the center of learning not only fosters independent thinking but also strengthens their ability to make informed judgments in both academic and real-life contexts.

3.2. Providing Comprehensive Information

Before one can critically assess a historical issue, it is essential to understand its broader background, conditions, and influencing factors. In other words, students must be fully informed about a particular historical process and its underlying dynamics in order to develop a sound dialectical perspective. Integrating multimedia and cross-disciplinary perspectives can help students form a multi-faceted understanding of historical events. Additionally, teachers can design assignments that require students to investigate both mainstream and marginalized narratives, allowing them to assess the complexity of historical truth. By engaging in this type of research, students not only accumulate factual knowledge but also develop an analytical mindset essential for nuanced historical criticism.

3.3. Encouraging Divergent Thinking

Critical thinking thrives on diverse perspectives and flexible thinking methods. Given that different individuals interpret the same historical events through various lenses, it is vital for teachers to encourage students to broaden their thinking and explore multiple angles when analyzing historical facts. This diversity of perspectives not only allows for intellectual collision and deeper discourse but also facilitates a more authentic reconstruction of historical narratives. By seeing through others' eyes, students can gain a deeper and more nuanced understanding of historical realities—enhancing both critical analysis and historical empathy. Encouraging students to consider "what if" scenarios can also lead them to think beyond fixed narratives and recognize the contingency of historical outcomes. For instance, asking how different decisions might have altered a historical event helps students challenge deterministic views and appreciate historical complexity. Through open-ended questioning and inquiry-based learning, students are prompted to investigate and reflect, which strengthens their creative and critical faculties. Ultimately, nurturing divergent thinking creates an inclusive classroom culture where all viewpoints are explored and valued.

4. Strategies for Cultivating Critical Thinking in Secondary History Teaching

4.1. Clarifying Instructional Objectives

To effectively develop critical thinking in history, teachers must first define clear teaching objectives and establish the overarching goals for critical skill development. With precise planning, educators can make full use of course content to stimulate students' inquisitive nature and questioning ability. On this foundation, students can be guided to debate established viewpoints and challenge conventional narratives, fostering genuine critical engagement. For instance, when teaching about the Yuan Dynasty's rule, teachers might define the objective as encouraging critical analysis of "political centralization," "civil service examination reforms,"

and “economic development.” Once key goals are identified, students can be invited to choose one area of personal interest and develop their own critique by comparing pros and cons, thus fostering independent historical thinking[13-14].

4.2. Enriching Classroom Historical Resources

To support critical thinking in history instruction, teachers should skillfully employ multimedia tools to access richer, more diverse historical content online. By integrating these resources into the classroom, students are provided with a broader and more authentic background for analysis. This stronger knowledge base allows for a more informed and credible development of critical thinking. Teachers can also prioritize controversial and multidimensional topics in their course planning. By selecting such content, and supplementing it with out-of-textbook sources, students are encouraged to engage in dialectical discussions from multiple perspectives. As a result, students’ comprehension, analytical reasoning, and critical thinking abilities can be greatly enhanced through exposure to varied materials and viewpoints.

4.3. Innovating Course Delivery Methods

To effectively cultivate students' critical thinking and overall competencies in secondary history classes, it is essential to innovate course delivery methods that stimulate students' interest in learning. Novel instructional formats offer more than just enhanced engagement; they also align with the conceptual underpinnings of critical thinking, which is closely linked to innovation and transformation. The development of critical thought often signals opportunities for reinterpreting and reimagining existing knowledge. Therefore, when teachers implement innovative teaching approaches, the instructional process itself becomes a vehicle for deeper historical understanding. Students are encouraged to adopt broader and more reflexive perspectives on past developments, which plays a vital role in fostering critical thinking (Table 1).

For example, when teaching the topic “The Intensification of Monarchical Autocracy in the Qing Dynasty,” instead of relying on conventional methods, educators can employ scenario-based teaching. By creating immersive historical situations, students are better able to grasp the nuances and controversies of the era. This approach not only deepens students’ comprehension of the content but also promotes the development of their analytical and critical skills, thereby enhancing overall classroom effectiveness.

Form	Description
Flipped Classroom	The teaching in the traditional classroom is moved to outside class, and students learn independently by watching teaching videos and other ways.
Project-based learning	The learning content is integrated with practical projects, allowing students to explore and apply knowledge in the process of completing projects.
Teamwork learning	Divide students into groups to study and solve problems together.
Technology assisted instruction	The use of virtual reality, augmented reality and other technologies to create an immersive teaching environment.

In summary, cultivating critical thinking in secondary history education is a complex and comprehensive endeavor. It requires teachers to approach instruction with thoughtful pedagogical design, guided by principles that foster an open and inclusive learning environment.
